



Third Party Providers

Bocking Primary School routinely shares data with the following third party providers. Where data is shared with a provider other than the DfE and Local Authority, sharing is restricted to the data being stored on the Providers systems in order to use their service. Third Party Providers do not have access to the data unless they have been given explicit permission in order to maintain the service or to fix faults with the service. All providers have been checked.

Provider **CPOMS Systems Limited** Service: CPOMS - A secure online system for the management and recording of child protection, behavioural issues, bullying, special education needs and any other pastoral or welfare concerns that may arise within the Academy. CPOMS allows employees to fulfil their obligation to report any concerns. Data includes names and contact details (if given) (Privacy Notice) Education Software Solutions Ltd (Privacy Notice) Services: 1. Pay360 Education Payments - A parent/employee-school portal which gives you the opportunity to pay for your child's lunch, school trips and other school services. Data shared includes pupil name and year group information (Privacy Notice) 2. SIMS Finance - A financial management system used by the school to collect and manage payments from parents, suppliers and customers. Data shared includes name, contact details and payment details ((Privacy Policy) eduFOCUS Ltd Service: EVOLVEvisits - An online management system used by the school to plan, risk assess, approve and manage off-site visits. Data includes names, contact details (if shared), identifiers (Privacy Notice) **Groupcall Xporter** Services: This is a data integrator tool used to manage selected third party providers and the school data they access from SIMS, such as DB Primary. Data includes name, academic year/class (Privacy Notice). **Inventry Ltd** Service: This is a secure sign-in system, which is used to monitor who is on site during the day for safeguarding reasons. The data is used via the Inventry Anywhere App to perform a roll call in the event of an emergency evacuation. Data includes name, emails (where provided), visitor details (name, company, Registration number, photograph), pupil details (name and class). (Privacy Notice) Juniper Education (formerly EES for Schools) Service: Target Tracker – A school analysis tool used by staff to monitor progress and identify areas that need further development. Data shared includes names, attainment data, and characteristics. (Privacy Statement) London Grid for Learning (LGfL) Service: 1. Free School Meals Eligibility Checker - An online free school meals checking service for parents to determine their eligibility. The service provides an instant decision on a parent eligibility. The results of the eligibility checks are instant and are used by the school to apply for additional funding for FSM and Pupil Premium. Data shared includes name and eligibility (<u>Privacy Statement</u>) Office 365 Service: Mail - A tool used by the school to communicate with parents. Data shared includes parent names and contact email. (Privacy statement)

- 1. DfE's Secure Access S2S This is a secure electronic data transfer site provided by the DfE in which schools can electronically pass historical information for pupils transferring schools, either from Primary to Secondary or from one Primary to another. Data includes pupil records, including attainment data.
- 2. Analyse School performance This supersedes Raise Online. It is a secure online tool providing data to schools to support their 'self-evaluation'. It aims to provide a common set of analyses for schools, local authorities, inspectors and School Improvement against which school performance can be measured. Data includes pupil attainment data.
